This agreement, entered into as of the day of, is between, thereafter referred to as "Coach", an individual serving the Texas United Football Club. The Coach represents that he/she is qualified and desires to perform the services required by the Club. The term is for ONE TUFC fiscal year that runs from July 1 st to June 30 th . Either party can terminate this agreement with 10 days written notice to the other party.						
I agree that I will abide by the rules of TUFC. Recognizing the possibility of physical injury associated with soccer, and in consideration for TUFC accepting the registrant for its soccer programs and activities (the "Programs") hereby release, discharge and/or otherwise indemnify TUFC and associated personnel, including the owners of the fields, and facilities utilized for the Programs, against any claim by or on behalf of the registrant as a result of the registrant's participation in the Programs and/or being transported to or from the same, which transportation I herby authorize.						
It is the intent of the TUFC to accept coaches, referees, administrators and volunteers without a prior history of violence, child abuse or neglect. The information given in this statement is subject to verification. This may include a criminal history check, verification of your motor vehicle record or publically available background check. The answers to these questions are truthful and correct.						
As a condition of volunteering, I give permission for TUFC to conduct a background check on me, which may include a review of sex offender registries, child abuse, and criminal history records. I understand that, if appointed, my position is conditional upon the league receiving no inappropriate information on my background. I hereby release and agree to hold harmless from liability TUFC, the officers, employees, and volunteers thereof, or any other person or organization that may provide such information. I also understand that, regardless of previous appointments, TUFC is not obligated to appoint me to a volunteer position. If appointed, I understand that, prior to the expiration of my term, I am subject to suspension by the Director of Coaches & Trainers (DOCT) and removal by the Board of Directors for violation of TUFC policies and principles.						
In consideration of the foregoing and the mutual promises and covenants set forth, the parties agree as follows:						
 All TUFC Coaches are volunteers and will not get paid for their services. Nor will they use any paid soccer trainers other than one of the approved soccer training firm's listed below.
